About the Contributors

Carol Ann Armenti, MA, JD is in private practice. Prior to establishing her current practice, she was a legal services staff attorney, whose practice consisted of representing low income individuals on healthcare matters. While there, she was President of the local bargaining unit of the Legal Service Workers, an affiliate of the United Auto Workers.
